The Council of the City of St. Albert, duly assembled, hereby ENACTS AS FOLLOWS:

- 1. Bylaw 13/2002, the Chief Administrative Officer Bylaw, is hereby amended by:
 - a. deleting the heading "FOIP Head" immediately before section 7 and replacing it with "Access and Privacy Head"; and
 - b. deleting the words "Freedom of Information and Protection of Privacy Act, R.S.A. 2000 c. F-25" at section 7 and replacing them with "Access to Information Act, SA 2024, c A-1.4 and Protection of Privacy Act, SA 2024, c P-28.5".
- 2. Section 16 of Bylaw 43/2021, the Chief Administrative Officer Bylaw, is hereby amended by deleting the words "Freedom of Information and Protection of Privacy Act" and replacing them with "Access to Information Act".
- 3. Bylaw 29/2024, Electronic Transmission of Assessment and Taxation Communication Bylaw, is hereby amended by:
 - a. deleting subsection 2.h in its entirety; and
 - b. deleting the words "FOIP Act" at section 18 and replacing them with "Protection of Privacy Act, SA 2024, c P-28.5, as amended".
- 4. Bylaw 2/2006, Records Bylaw, is hereby amended by:
 - a. deleting the words "the Freedom of Information and Protection of Privacy Act does" in the recitals and replacing them with "provisions of applicable access to information and protection of privacy legislation do"; and
 - b. deleting subsection 3.a in its entirety.



5. The Chief Administrative Officer is authorized to issue a consolidated version of Bylaw 13/2002, Bylaw 43/2021, Bylaw 29/2024, and Bylaw 2/2006 that incorporates the amendments made by this amending bylaw and otherwise conforms with the requirements of section 69 of the *Municipal Government Act*.
