The CSAC has recommended funding for the 2021 Outside Agency Grant program as follows:

## **Application #1 –** St. Albert Bereavement Fellowship

- Funding Request: \$8,000
- Eligible Grant Amount: \$7,668
- CSAC Recommended Funding: \$7,668
- The funding is in support of four contract staff and insurance.

## **Application #2 –** St. Albert Housing Society

- Funding Request: \$63,025
