The Government of Canada provides funding to the Province, which is delivered through the Grant in order to reduce parents' fees to a standardized monthly flat rate – in June 2025, this rate is \$326.25 per child (full-time); prior to this initiative, such costs were upwards of \$1,000 per month.  Federal funding includes a maximum number of for-profit child care spaces eligible for funding; consequently, given Alberta's funding allocation is approaching this maximum, the Province decided to limit which new for-profit spaces receive the remaining funding – this has particularly impacted new entrepreneurs and start-ups that were relying on the promise of this funding as part of their business model.
