The following facilities, identified on the Chart as ready for opening, will be opened for public use as soon as practicable and in any case not later than 8 AM on Saturday May 16, under conditions of use approved by the Director of Emergency Management that are consistent with current Orders and recommendations of the Provincial Ministry Health: 4 of the 6 pickleball courts and the Tennis Courts at Larose and all of the tennis courts at Willoughby

6 of the 12 pickleball courts at Alpine and the remainder of the tennis courts in St. Albert shall open in a staged approach, no later than by 8am on May 23, implementing recommendations and conditions imposed by the provincial health authority and the CMOH.

Outdoor playgrounds shall remain closed to the public at this time and Administration is requested to seek approval from Alberta Health for a playground re-opening plan that does not require regular cleaning of the play structures but does require posting of the proposed signage presented to the Committee at the May 14, 2020 meeting, and playgrounds shall open only after approval from Public Health for the re-opening plan has been received.
