AR-20-098 Recreation Parks and Culture Facilities, Programs and Events

Moved by Councillor Joly

That Council approves the following cancellations and postponements:

- a) Indoor municipally operated and partner operated recreation and cultural facilities that are currently closed remain closed until May 31, 2020;**
- b) All business lease holders within indoor recreation facilities that are currently closed remain closed until May 31, 2020 with the exception of Active Physio Works;**
- c) All recreation and cultural facility bookings cancelled until May 31, 2020 in alignment with facility closures;**
- d) The recreation, fitness and aquatic spring program session, March 30- June 28, 2020 be cancelled;**
- e) The culture spring program session March 30 - June 20, 2020 be cancelled;**
- f) All community and City lead events be cancelled until May 31, 2020;**
- g) The following City operated outdoor seasonal recreation facilities be closed until May 31. Fowler Athletic Park, Larry Olexiuk Field, tennis courts, pickleball courts, Skateboard Park, Woodlands Water Play Park, Grosvenor Outdoor Pool, sport fields, ball diamonds and picnic shelters, pavilions.**
- h) The following community partner operated outdoor seasonal facilities would be closed until May 31. St. Albert BMX Association, Mission Tennis Club, St. Albert Men's Slowpitch Association, BLESS programming at the Log Cabin, Heritage Sites and Grain Elevator Park.**
- i) The following business lease holders in outside recreation facilities will be closed until May 31; Punky Potatoes at Larry Olexiuk Field, Splash Pad at Woodlands Water Play Park and Grosvenor Outdoor Pool**
- j) That the above note cancellations and postponements can be updated or changed based on the recommended advice of Alberta Health Services, Alberta Emergency Management Agency or the City's Director of Emergency Management.**

That Council approve parks, trails, boat docks and playgrounds remain accessible to the public for spontaneous use with social distancing practices in

place, unless further directed by Alberta Health Services, Alberta Emergency Management Agency or the City's Director of Emergency Management.

That Council approve the spring grant application deadlines be extended until April 25, 2020 for Community Capital Grant, Community Events Grant, Athlete and Artist Development Grant programs.

That Council approve the spring grant application for the Young Artist Legacy Awards be extended to May 14, 2020 and the Poet Laureate proclamation to be extended to a suitable Council meeting in May 2020.

That Council approve additional bridge funding in the amount of \$11,300 to CIVC to support the operation of Sidekicks mentoring program until a new grant agreement is executed with the successful organization.
