# **Administrative Report**

A. Giesbrecht provided an update on Next Generation 911. In collaboration with the RCMP and K-Division, the Next Generation 911 system is scheduled for implementation on November 17, 2025. Although updates will not be significant until additional municipalities adopt the system, eventually it will enable 911 text messages and video submissions, and calls placed from cell phones will provide dispatchers with precise coordinates and, in the future, elevation details.
