

Affordable Housing Grant Funding Motions

The following motions have been approved by Council:

September 24, (C523-2007)

2007

That the Affordable Housing Funding Plan for Year 1 of the Municipal Sustainability Housing Program and Capital Enhancement Program 2007/08 be approved and submitted to the Minister of Municipal Affairs and Housing for a decision.

(C524-2007)

That the policies relative to the Affordable Housing Funding Plan be presented to Council prior to implementation.

(C526-2007)

That administration, with regard to the secondary suite program, establish the following elements of the policy:

- cut off date for all applicants by category; and
- awarding of the contract using length of time of guaranteed below market rents.

That the Basement Suite Grant Program be approved.

(C173-2008)

That the Transitional Housing Grant Program be approved.

(C175-2008)

That Administration negotiate the purchase of property or properties for affordable housing and that top priority be given to initiate a Habitat for Humanity project subject to City Council's approval at a regular Council meeting.

(C176-2008)

That the 30 percent matching funds for land purchase to a maximum of \$274,468 be approved with funding as follows: \$75,000 from the Future Capital Carry Forward Reserve and \$199,468 from the 2008 Municipal Capital Fund.

That \$204,510 be transferred from the Stabilization Reserve to the municipal fund to offset fees and charges that will be incurred by the Sturgeon Foundation for the proposed addition to the North Ridge Lodge.

That the City's contribution towards the St. Albert Housing Society funding request in response to the September 19, 2008 Provincial Affordable Housing Request for Proposals be \$150,000, to be transferred from the 2007 Affordable Housing Capital Project Budget.

That the Affordable Housing plan for Year 2 of the Provincial Municipal Funding Program be approved for submission to the Minister of Housing and Urban Affairs for a decision; and that \$6,760 in Administration costs over and above the 1.5% allowed through the Provincial Municipal Funding Program be funded from a transfer from the Council Contingency Account.

- a. that the St. Albert Housing Society's 2009 Request for Proposal submission to the Province be awarded grant funding;
- b. that the Minister approves the City of St. Albert Year 3 Affordable Housing Plan;
- c. that the Minister approves the proposed amendments to the City of St. Albert Year 1 and Year 2 Affordable Housing Plans; and,
- d. that the St. Albert Housing Society comply with the conditions set by City Council through Resolution C534-2008.

April 26, 2011	<u>(C272-2011)</u> That the transfer of uncommitted affordable housing grant funding to the Transitional Housing Rental Assistance Program in the amount of \$185,000 be approved. <u>(C273-2011)</u> That the transfer of uncommitted affordable housing grant funding to the Basement Suite Grant Program in the amount of \$229,351 plus future earned interest from the Affordable Housing Grant be approved. <u>(C277-2011)</u> That \$10,900 in Administration costs for the Transitional Housing Rental Assistance Program be funded from Year 1 municipal administration funding. <u>(C278-2011)</u> That the amendments to the 2007/2008 and 2009/2010 Affordable Housing Program Agreements be approved for submission to the Minister of Housing and Urban Affairs for approval prior to implementation.
June 27, 2011	<u>(C274-2011) (originally made on April 26, 2011)</u> That the transfer of uncommitted affordable housing grant funding to Habitat for Humanity in the amount of \$515,000 be approved. <u>(C405-2011)</u> That consideration of Motion C274-2011 be further postponed to July 4, 2011.
July 4, 2011	<u>(C425-2011)</u> <ol style="list-style-type: none"> 1. That the Sturgeon Foundation be allocated \$257,000 towards their 2011 RFP application for St. Albert. 2. That the St. Albert Housing Society be allocated \$258,000 towards their Big Lake Pointe 2011 RFP.

(C427-2011)

That, if either/both above project/s do/es not receive funding the funds be reallocated by Council.
