CITY OF ST. ALBERT BYLAW 25/2017

Being Amendment 17 to the Business Licensing Bylaw 43/2000

The Council of the City of St. Albert, duly assembled, hereby ENACTS AS FOLLOWS:

- 1. Bylaw 43/2000, the Business Licensing Bylaw, is hereby amended by this Bylaw.
- 2. Section 2, Definitions is amended by:
 - a) Inserting the following new definitions in alphabetical order:
 - i) "Business License" means a license to operate a Business, as issued in accordance with this Bylaw;
 - ii) "License Holder" means the Person to whom the applicable Business License has been issued:
 - b) Deleting the definition for "Not For Profit Organization" and replacing it with the following:
 - "Not For Profit Organization" means a non-profit organization as defined in the *Municipal Government Act*, R.S.A. 2000, cM-26;"
 - c) Deleting the definition for "Peace Officer and replacing it with the following:
 - "Peace Officer" means a peace officer as defined in the *Provincial Offenses Procedure Act*, R.S.A. 2000, c P-34."
 - d) That all subsections be renumbered accordingly.
- 3. a) Subsection 7(1) is amended by deleting the word "and" at the end of (d) and adding the following new subsections (e) and (f):
 - "(e) a Person whose Business is carried on as part of a special event permitted by the chief administrative officer or designate;



- (f) a Person whose Business is carried on as part of the St. Albert Farmer's Market, and"
- b) That the remaining subsection be renumbered accordingly.
- 4. Subsection 10(5)(c) is amended by deleting the words "the regulation of a business" and replacing them with "Regulated Business".
- 5. Section 12 is amended by:
 - a) deleting subsection (2) in its entirety and replacing it with the following:
 - "(2) A separate Business License is required for each location in the City where that Business is carried on."
 - b) adding the words "the new transferee" following the words" the license holder" in subsection (5).
- 6. Subsection 14(1)(a) is deleted in its entirety and replaced with the following:
 - "(a) this Bylaw, including additional requirements of any Schedule appended to and forming a part of this Bylaw; and"
- 7. Sections 24, 25, 26 and 27 are deleted in their entirety.
- 8. Schedule A is amended by:
 - a) Deleting 1. in its entirety and replacing with the following:
