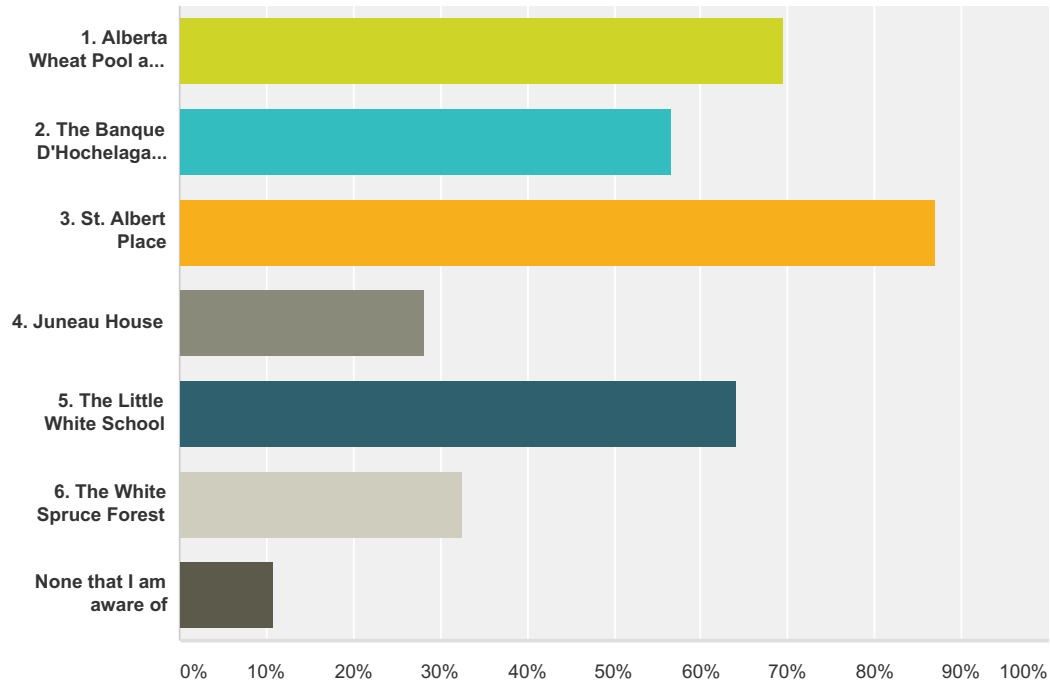


Q1 Have you visited a designated Municipal Historic Resource in St. Albert? Please check all that apply.

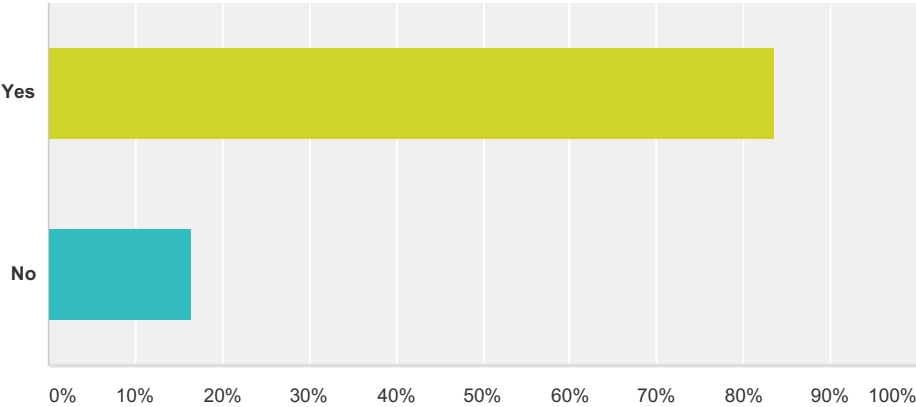

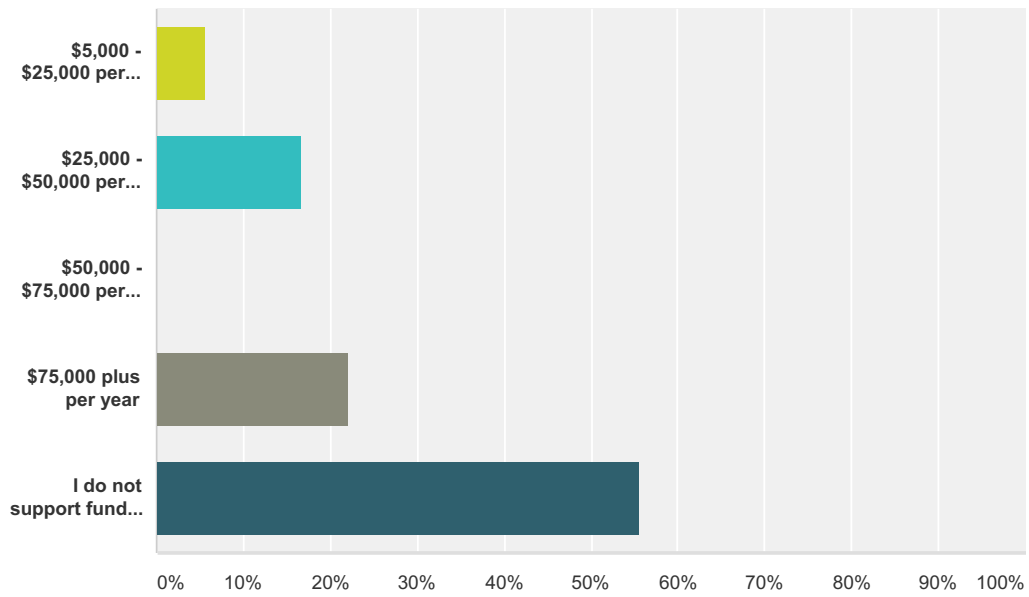

Q3 If not, what level of funding do you feel is appropriate?

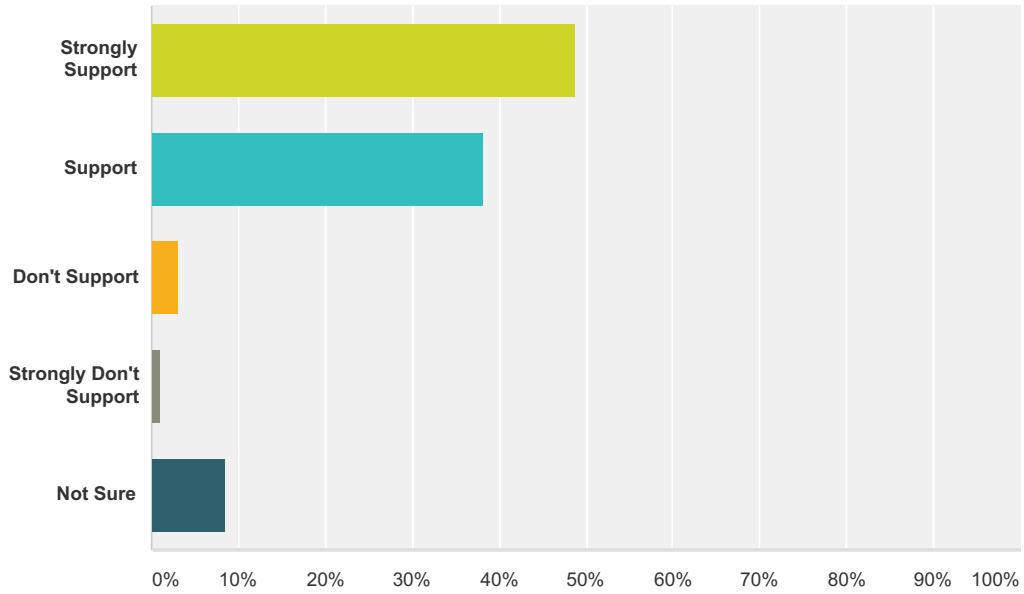

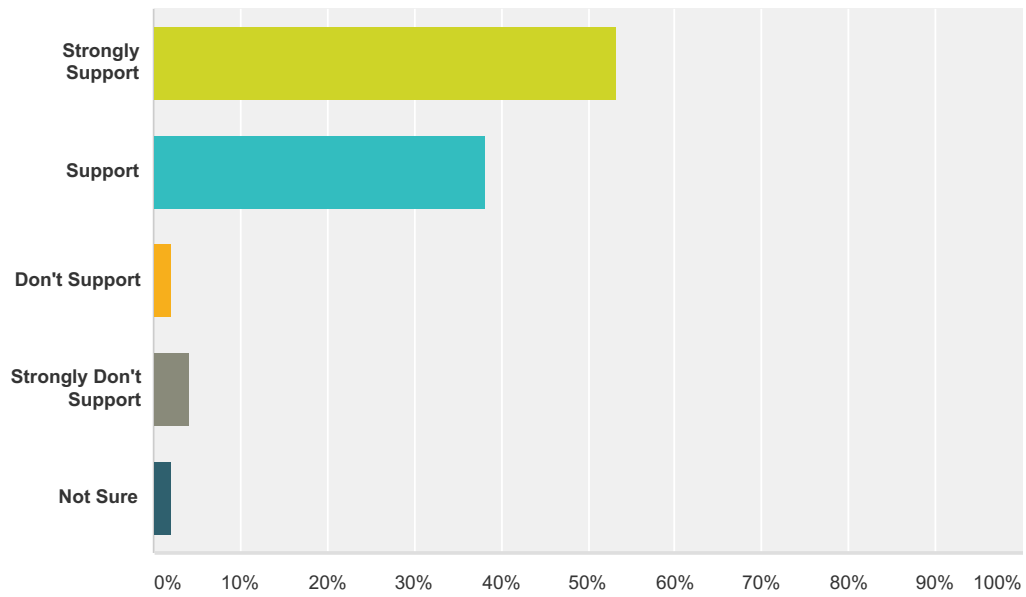

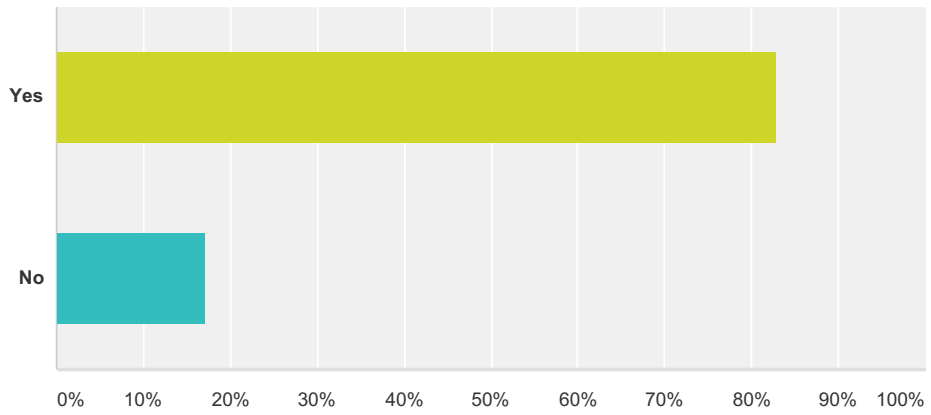
