BACKGROUND AND DISCUSSION

Currently Bylaw 31/2017 Governance, Priorities and Finance Committee does not align with the

procedures for public presentations set out in the Procedure Bylaw for Council Meetings. In an effort to create consistency and clarity, Bylaw 46/2018 would amend Bylaw 31/2017 to remove any inconsistent references to procedures for public presentations.

Section 12 indicates that "Except as modified by specific provisions of this Bylaw, the Committee shall conduct itself in accordance with the Procedure Bylaw", thereby ensuring consistency with Council meetings with respect to public presentations. Proposed new Section 12.1 would clarify the slightly inconsistent terminology between Council and Committees meetings (i.e. "Mayor" vs. "Chair" and "Council" vs. "Committee").

Also, based on overall review of the bylaw a few other minor amendments are proposed to make the bylaw clearer and flow more logically. An amendment to the preamble is also proposed so that GPFC will be described as assisting Council with governance, not operations.
