## BYLAW 35/2019 Being Amendment 21 to Water Bylaw 5/2001

The municipal council of the City of St. Albert ENACTS AS FOLLOWS:

- 1. The Water Bylaw 5/2001 is hereby amended.
- 2. The following new definitions are added to section 2(1):
  - (f.1) "Non-Standard Meter Reading" means the reading of a water meter which is not a component of the City's advanced metering infrastructure and therefore requires a site visit from an employee or agent of the City, carried out by visual inspection of the water meter or by means of a Remote Reading Device;
  - (f.2) "Non-Standard Meter Reading Program" means a program under which a Customer receives Non-Standard Meter Readings bi-monthly, with the Customer submitting their own meter reading to the City in alternate months;
  - (g.1) "Remote Reading Device" means an encoder-type remote registration system from which a numerical meter reading or a recording of a meter reading in an electronic data-storage medium can be obtained semiautomatically or automatically at a location that can be remote from the meter;
  - (g.2) "Standard Meter Reading" means a reading of a water meter that does not require a site visit by an employee or agent of the City, carried out by means of advanced metering infrastructure installed by the City;
- 3. Subsection 21(1) is deleted and replaced with the following:
  - 21(1) The City will endeavour to obtain a reading of water consumption measured by a water meter at least once per month which in the case of the Non-Standard Meter Reading Program includes a meter reading submitted to the City by the Customer in alternate months.
- 4. A new subsection Section 21(4) is added as follows:
  - 21(4) A Customer may opt to have their water consumption measured under the Non-Standard Meter Reading Program, and in such case the Customer shall pay for Non-Standard Meter Readings at the rate per meter read set out in Schedule A and shall also pay the fee set out in Schedule A for bimonthly meter reading submissions by the Customer.



5. Schedule "A" is deleted and replaced with the Schedule "A" attached to this bylaw.
