### BYLAW 42/2019

#### BUSINESS LICENSE BYLAW AMENDMENT

Being Amendment 22 to the Business License Bylaw 43/2000

---

The Council of the City of St. Albert ENACTS AS FOLLOWS:

1. Bylaw 43/2000, the Business License Bylaw. is amended by sections 2 through 6 of this Bylaw.
2. Subsection 2(l) is amended by inserting the words “and Schedule “D”” after “Schedule “A...”” and before “...in.”
3. A new section 6.1 is added as follows:
  - 6.1 (1) *No Person may engage in or operate a Business listed in Schedule “D”.*
  - (2) *No Person may advertise or offer a Business listed in Schedule “D” to minors.*
4. A new subsection 21(a.1) is added as follows:

21 (a.1) *to a fine prescribed elsewhere in this Bylaw;*
5. A new section 21.1 is added as follows:

21.1 *Notwithstanding subsection 21(a) the minimum fine for a Person who is found guilty of an offence under section 6.1(2) is \$10,000.00.*
6. A new Schedule “D”, attached hereto, is added to the Bylaw.
7. The Chief Administrative Officer is authorized to issue a consolidated version of Bylaw 43/2000 that incorporates the amendments made by this Bylaw.

## Schedule “D”

### Prohibited Businesses

Business	Prohibited Business Activity
Conversion Therapy	<p>Offering or providing of counselling or behavior modification techniques, administration or prescription of medication, or any other purported treatment, service, or other thing for the purpose of changing an individual’s sexual orientation, gender identity, gender expression, or gender preference, or for the purpose of eliminating or reducing sexual attraction or sexual behavior between individuals of the same sex, but not including</p> <ul style="list-style-type: none"><li>a. services that provide acceptance, support, or understanding of an individual or that facilitate an individual’s coping, social support, or identity exploration or development, or</li><li>b. gender-affirming surgery or any service related to gender-affirming surgery.</li></ul>
