BACKGROUND AND DISCUSSION

The 3-year work plan was developed on Saturday, October 26, 2018 in a facilitated session of Committee members and Environment staff. The work plan was developed to provide a longer-term picture of the EAC's work load and identify potential priority areas for the next three years.

The EAC approved their 2019 annual report and proposed 2020 priorities at their November 28, 2019 meeting. The EAC includes seven representatives from the public and one Councillor. OVERVIEW

The Environmental Advisory Committee (EAC) was established through Bylaw 29/2005 to advise Council on issues related to the environment. The purpose of the Committee is to provide advice to Council with respect to environmental policies, plans, and initiatives, especially where a public perspective is desirable.

Direction and assistance to the EAC were obtained through the City's Utilities and Environment Department staff.

On January 21, 2019 Council provided the EAC with the following annual priorities:

- Recommend the 2019 Environmental Initiatives Grant Program recipients;
- Provide advice on environmental policies included in the Municipal Development Plan;
- Provide advice on leadership opportunities in waste (Council priority); and
- Provide advice on the Parks Bylaw and Fire Bylaw reviews and PACE Bylaw development.

ACTIVITIES PROGRESS REPORT

The Environmental Advisory Committee met nine times during 2019, meeting monthly except in July, August, and December.

Priorities – Advice to Council

Environmental Initiatives Grant Program Recommendations

The EAC continued with its major function, namely reviewing applications submitted under the City's Environmental Initiatives Grant Program (EIGP) and providing funding recommendations to Council. A one-time submission of applications was received on October 10, 2019 for the EIGP in accordance with existing Council Policy C-EUS-02. The EAC reviewed 17 applications totalling \$93,832.91 in requested funds and 11 were recommended for funding totalling \$32,200.

Community Recognition Program Recommendations

New in 2019, the Environmental Advisory Committee reviewed the nominations under the environmental stewardship category of the City's Community Recognition Program. The addition of the environmental stewardship category to this program was a recommendation from the EAC 2018 work plan (environmental leadership recognition).

At the March 28, 2019 EAC meeting, the Committee met in camera to review three submissions in accordance with Council Policy C-CS-03 and two were recommended to City Council for recognition.

On June 17, 2019, City Council presented the following individuals the Community Recognition Program award in the environmental stewardship category:

- Daryl D'Amico Daryl is a St. Albert resident that has served on the Grey Nuns White Spruce Park (GNWSP) Working Group since 2012. Daryl was instrumental in the designation and naming of GNWSP and the continuous work to protect and manage the historically significant white spruce forest.
- Leah Kongsrude Leah is a St. Albert resident who worked for the City of St. Albert in the Environment for over 13 years. Leah's legacy in St. Albert not only lies in her community and professional work, but the leadership for the

projects and initiatives that improved and protected the long-term health of the environment in St. Albert. Her passion and energy for environmental work in St. Albert was empowering to others to become involved.

Environment Bylaw and Policy – 4 Year Review

City staff are required to review bylaws and Council policy every four years. In 2019, the environmental documents for review included Environmental Initiatives Grant (EIG) Council Policy, Environmental Advisory Committee (EAC) Bylaw and the Environmental Sustainability Policy. At the February 28, 2019 EAC meeting, the Committee reviewed the three environmental documents and determined that the EAC Bylaw and EIG Council Policy do not require any changes and that the Environmental Sustainability Policy should be reviewed in more detail.

At the April 25, 2019 EAC meeting the Committee reviewed the policy and discussed changes. A red-lined version of the policy was developed and approved at the May 23, 2019 EAC meeting and forwarded to City Council for approval on August 26, 2019.

Flyer Opt-In

At the November 28, 2019 meeting, staff from Economic Development, M. Killoh and N. Pearson, presented background information and preliminary research on the flyer distribution opt-in Council motion. EAC provided written advice (Appendix I) to Economic Development to include in the report to Council February 2020.

Fire Bylaw and Parks Bylaw Reviews

The review of the Fire Bylaw and Parks Bylaw was postponed to 2020 and will be added to the Committee's work plan.

EAC Input Provided to Administration

Environmental Initiatives Grant Program Promotions

January 24, 2019 – to encourage potential applicants and promote innovative projects for the 2019 allocation of the Environmental Initiatives Grant Program, EAC developed a project idea list to be used by administration for grant promotions. In addition, EAC decided to offer an Application Mentor Program for applicants to discuss and review their project ideas with Grant Review Members. EAC members also attended the Grant Information Session to answer potential applicants' questions and provide them with suggestions on their project ideas.

Municipal Development Project Champion Team

In 2019, Brad Peori represented the Environmental Advisory Committee on the Project Champion Team for the Municipal Development Plan project, Flourish Growing to 100k.

Municipal Development Plan

March 28, 2019 – Kristina Peter (Manager, Planning) and Carley Holt (Planner), introduced the Municipal Development Plan (2000) and presented the project for the development of a new MDP (Flourish: Growing to 100K). The Committee received growth scenarios based on a population of 100000 around the year 2044 and provided suggestions based on the areas west, north and in the core.

Annual Report on the Environment

March 28, 2018 – Committee received a summary of the 2018 Report on the Environment published annually to update residents on the goals and targets set in the Environmental Master Plan. The Committee provided suggestions for incorporation into the following years report.

Local Action Plan for Energy Conservation and Reducing Greenhouse Gas Emissions

May 23, 2019 – Committee reviewed and provided input on an update to the Local Action Plan for Energy Conservation and Reducing Greenhouse Gas Emissions (2013), specifically the energy conservation measures for both the corporation and the community.

Public Participation Target

May 23, 2019 – Committee discussed the public participation target in the Environmental Master Plan (EMP) and provided suggestions on how to meaningfully track and report on environmental stewardship until the update of the EMP in 2020.

Smoking Bylaw

June 27, 2019 - Darija Slokar (Senior Advisory & Project Manager, Corporate Initiatives) and Marta Caufield (Deputy City Solicitor, Legal Services) provided background on the Smoking Bylaw amendments and solicited feedback from Committee members. The Committee discussed environmental impacts of the bylaw amendments, specifically littering and air quality. This engagement was completed on the EAC's environmental tour bus.

Updates Provided to EAC

Transportation Master Plan

February 28, 2019 – Dean Schick, Manager, Transportation, presented on the work completed on the Transportation Master Plan included an implementation plan overview and priority deliverables (road network, Intelligent Transportation System, public transportation, goods movement/network function, and active modes).

Property Assessed Clean Energy (PACE)

February 28, 2019 – Christian Benson, Manager, Environment provided an update on the PACE program now called Clean Energy Improvement Program (CEIP). The City of Edmonton scheduled to complete a pilot in 2020 and St. Albert (specifically C. Benson) is on an advisory committee in the Capital Region and will update the EAC as information becomes available.

CN Railway Fence

February 28, 2019 – EAC discussed the development of a fence along the CN railway going through St. Albert.

Relevant motion from March 28, 2019 EAC meeting:

That EAC requests a City representative attend the September 26, 2019 EAC meeting to identify issues of wildlife connectivity and mitigation methods for the CN fence.

September 26, 2019 – Melissa Logan, Environmental Coordinator – Sturgeon River & Natural Areas, provided a brief presentation on results of the wildlife cameras set up along the CN fence within City limits.

River Water Quality Index

April 25, 2019 – Melissa Logan, Environmental Coordinator – Sturgeon River & Natural Areas, presented on the River Water Quality Index, a tool developed to communicate the health of the Sturgeon River.

Net Zero Residential Development

April 25, 2019 – Christian Benson, Manager, Environment, introduced the Net Zero Residential Development Council priority project. Net zero refers to a home that produces as much energy as it consumes on an annual basis.

Environmental Projects Tour

June 27, 2017 - the Committee went on a scheduled tour and stopped at three locations of interest. The first was the City's air quality monitoring station behind the Sturgeon Reservoir with Farron Bibby, Air Quality Monitoring Technologist with Alberta Environment and Parks. At second stop they toured the net-zero home at 10 Legacy Terrace by the home owner and the home designer. Lastly, the City's Utilities Manager Brian Brost gave the Committee a tour of the Lacombe Park Reservoir and Pump Station.

Grey Nuns White Spruce Park - Project Update

September 26, 2019 – Erin Pickard, Operations Supervisor, Parks & Open Spaces provided an overview of the history of Grey Nuns White Spruce Park and an update on the projects within the area (grant funding, trial plots, cone collection and extraction, seedling orders, planting through reforestation companies, partnerships, snag and fallen tree management).

Urban Forest Management Plan - Update

November 28, 219 – Louis Stewart, Senior Manager, Public Works Operations and Erin Pickard, Operations Supervisor, Parks and Open Spaces presented on the Urban Forest Management Plan, approved in 2017 and the progress on the four goals within the plan.

3-YEAR WORK PLAN

In October 2018, EAC completed a 3-year work plan for 2019-2021. The purpose of the work planning session included:

- To update the EAC 3-year work plan developed in 2016;
- Reaffirm Committee's role (Bylaw 35/2015);
- Determine Committee's planned actions for next 3 years based on the Environmental Master Plan;
- Ensure Committee's work is aligned with major City plans and guiding environmental plans; and
- Provide advice to Council priorities related to environment.

The EAC 3-Year work plan 2019-2021 summary is attached in Appendix II.

2020 Priority Recommendations

These are the major environmental initiatives that are being developed in 2020 that require in depth formal involvement from EAC and written advice to Council.

- 1. Recommend 2020 Environmental Initiatives Grant Program and Community Recognition Program (environmental stewardship category) Recipients

- 3. Provide advice on the Single Use Item Reduction Strategy
- Provide advice on the Parks Bylaw and Fire Bylaw reviews and PACE/CEIP Bylaw development

The EAC acknowledges the dedication and competency of the City of St. Albert's Utilities and Environment staff throughout 2019 as well as their ongoing support towards the Committee. It is through the efforts of the Utilities and Environment department, that important sustainability focused programs are developed and put into practice in the community to ensure resilience.

APPENDIX I – WRITTEN ADVICE TO COUNCIL

WILDNorth – Environmental Initiatives Grant Program

Recommendation – approved October 24, 2019

As part of the overall funding recommendations, EAC has provided the following statement to be included in the agenda report to City Council:

EAC recognizes the importance of WILDNorth in providing wildlife rescue and rehabilitation services in St. Albert and recommends that City Council considers allocating sustainable funding to WILDNorth outside the Environmental Initiatives Grant Program.

EAC acknowledges that WILDNorth contributes an important service to St. Albert by providing care to injured and orphaned wildlife with the goal of returning these wild animals to their natural habitat. In the last two years, EIGP funding has been allocated in recognition of the essential service provided by WILDNorth.

Opt-In Flyer Distribution

Recommendation – approved December 2019

The Environmental Advisory Committee (EAC) appreciated Economic Development's presentation regarding the City of St. Albert's research into an "opt-in" program for flyers. The EAC recognizes that the distribution of flyers consumes a large amount of paper and energy. As such, the EAC is supportive of measures which will enable residents to reduce their consumption of flyers. The Committee is happy to provide further advice should this proposal move forward.

Bylaw 35/2015

Being a bylaw to establish and define the functions of the Environmental Advisory Committee and to repeal Bylaw 29/2005

WHEREAS Section 145 of the Municipal Government Act, R.S.A. 2000, c. M-26, provides that Council may pass bylaws to establish council committees and define their functions.

AND WHEREAS Council wishes to establish a council committee to advise Council on issues related to the environment.

The Council of the City of St. Albert, duly assembled, hereby ENACTS AS FOLLOWS:

Title

1. This Bylaw may be referred to as the "Environmental Advisory Committee Bylaw".

Definitions

- 2. In this Bylaw:
 - (a) "Bylaw" means this Environmental Advisory Committee Bylaw;
 - (b) "Chair" means the chairperson of the Committee;
 - (c) "City" means the municipal corporation of the City of St. Albert or, where the context so requires, the area contained within the boundaries of the City;
 - (d) "Committee" means the Environmental Advisory Committee established by this Bylaw;
 - (e) "Councillor" means an active member of Council;
 - (f) "Environmental Master Plan" means the City of St. Albert's primary directional plan that primarily supports the achievement of the community's natural environmental pillar. The goals and strategies indentified within the plan inform the City of St. Albert Strategic Plan.
 - (g) "Interested Party" means an individual or group specifically invited by the Committee to attend a specified Committee meeting to address an item on the Committee's agenda;



- (h) "Member" means a member of the Committee;
- (i) "Members of Council" means the municipal council of the City of St. Albert;
- (j) "Procedure Bylaw" means Bylaw 3/2018 and includes any amendments or successor bylaws thereto; (BL 41/2019)
- (k) "Standing Committee" means the standing committee established pursuant to the Community Living Standing Committee Bylaw 39/2019; and (BL 41/2019)
- (I) "Term" means a Member's term of office.

Committee Establishment

3. There is hereby established a Council committee that shall be referred to as the Environmental Advisory Committee.

Appointments and Membership

- 4. Members shall be appointed annually by Council resolution.
- 5. The Committee shall consist of the following 8 members:
 - (a) 7 residents of St. Albert; and
 - (b) 1 Councillor, who is entitled to be recognized by the Chair for participation in debate or discussion on any matter before the Committee but may not make motions or vote. (BL 41/2019)
- 6. Members of Council not appointed as a Member may attend any regular Committee meeting, including any *in camera* session, but may not debate, make motions or vote on any issue before the Committee.

Terms

- 7. Except where a Member is appointed to fill a membership vacancy,
 - the term for the Members appointed under section 5 (a) shall be two
 years commencing January 1 of the effective year of appointment; and
 - (b) the term for the Member appointed under section 5 (b) shall be one (1) year commencing on the date of Council resolution.



- 8. Other than a Councillor, no individual may serve as a Member in excess of 3 consecutive Terms.
- 9. In the event a Member:
 - (a) fails to attend 3 consecutive regular meetings of the Committee, without the permission of the Committee;
 - (b) ceases to be a resident of the City; or
 - (c) is hired in any capacity by the City;

the appointment of that Member shall, without further action, be revoked and the position of that Member shall be deemed to be vacated. Section 9 does not apply to the Councillor who has been appointed to the Committee.

Vacancies

- 10. (1) Notwithstanding the foregoing sections, if, for any reason, a Member vacates his or her membership on the Committee part of the way through that Member's Term, Council shall appoint as a replacement Member
 - (a) a resident of St. Albert; or
 - (b) a Councillor, if the vacating Member is a Councillor.
 - (2) The replacement Member referred to in subsection (1) shall serve the remainder of the vacating Member's Term.

Non-Voting Participants and Attendees

- 11. Representatives from the City's Environment Branch shall attend regular Committee meetings, including any *in camera* session, and act as a resource and facilitator for the Committee but may not make motions or vote on any issue before the Committee.
- 12. To ensure the Committee is properly informed and engaged, the Committee may take the opportunity to invite representatives from organizations, institutions and government agencies to attend any regular meeting, but those representatives may not make motions or vote on any issue before the Committee.
- 13. The Committee may invite an Interested Party to speak to an issue before the Committee but the Interested Party may not make motions or vote on any issue before the Committee.



Quorum, Meetings and Rules of Procedure

- 14. A quorum at any Committee meeting shall be four voting Members of the Committee.
- 15. (1) At the first meeting of each calendar year, the Members of the Committee shall elect one Member as Chair and one Member as Vice Chair who shall act in the absence of the Chair.
 - (2) Should the Chair or Vice Chair position be vacant, a representative from the City's Environment Branch shall act as Chair until a Chair is elected.
 - (3) The Councillor shall not be Chair.
 - (4) The Chair or other Committee Member designated by the Chair shall be spokesperson for the Committee to the public.
 - (5) The City may disqualify a Member from participating in a procurement process if the City, in its sole and absolute discretion, determines that the Member's participation in the Committee constitutes or could be seen to constitute a conflict of interest or give or could be seen to give the Member an unfair advantage in a procurement process.
- 16. The Committee shall meet no less than 4 times a year.
- 17. (1) The Chair may call for a meeting of the Committee at any time.
 - (2) Within thirty (30) days of receiving a written request from a Member of the Committee or City Council that the Committee hold a meeting on a particular issue, the Chair shall call a meeting of the Committee to address the issue identified in the request for the meeting and such other matters as the Chair may consider appropriate.
- 18. The Committee shall conduct its meetings in accordance with the Procedure Bylaw.

Committee Roles and Responsibilities

- 19. The Committee shall:
 - (a) provide strategic advice and input on the development and implementation of the Environmental Master Plan and other related environmental and sustainability issues to Council or the Standing Committee; and (BL 41/2019)



- (b) provide input to Administration during the development of Council and administrative policies, plans and initiatives; and
- (c) provide feedback on public engagement and the public perspective on how particular environmental and sustainability issues impact the community and other City plans, recognizing that many of the issues are of regional, national and global concern; and
- (d) provide written advice and recommend priorities. Priorities are determined by:
 - (i) the action plan of the Environmental Master Plan;
 - (ii) review periods for the Environmental Master Plan, policy or bylaws;
 - (iii) issues as requested by approved Council motions; and
 - (iv) Council approved priorities;
- (e) form Sub-Committees to review and comment on specific environmental and sustainability issues referred to that Sub-Committee by the Committee; and
- (f) review applications received under the Environmental Initiatives Grant Program and make recommendations to Council or the Standing Committee. (BL 41/2019)
- (g) Deleted (BL 41/2019)
- 19.1 The Chair shall provide an in-person report to the Standing Committee at least once per year regarding:
 - (a) the Committee's progress and activities over the past year relative to its mandate;
 - (b) issues of significance to the Committee; and
 - (c) the Committee's work plan for the upcoming year, including the Committee's annual priorities and goals. (BL 41/2019)
- 20. The Committee may:
 - (a) recommend sources of funding to support environmental and sustainability initiatives; and
 - (b) recommend partnerships with environmental interest groups, community groups, and other levels of government.



Bylaw 29/2005

21. Bylaw 29/2005 is repealed upon this Bylaw taking effect.
