BYLAW 30/2020

TRAFFIC BYLAW AMENDMENT

Being Amendment 15 to the Traffic Bylaw 18/2005

The Council of the City of St. Albert, duly assembled, hereby ENACTS AS FOLLOWS:

1. Bylaw 18/2005 Traffic Bylaw is hereby amended by this Bylaw.
2. A new section 46.1 is added as follows:

Temporary Permit – Selling on Street or Sidewalk

- 46.1 (1) No Person shall by any means sell anything whatsoever upon any Public Place in the City unless a permit has been granted by the City Engineer.
- (2) The City Engineer may, in their discretion, issue a permit, refuse to issue a permit, or issue a permit upon such conditions as they deem appropriate.
- (3) Without restricting the generality of subsection 46.1(2), all permits issued shall be terminable immediately upon a breach of any condition of the permit by the applicant.
- (4) Section 46.1 of the Bylaw will cease to have effect at 11:59:59 PM on October 15, 2020, unless the operation of this section is extended by a resolution of Council.

3. Section 67 is amended by adding a new subsection 67(d.1) as follows:

67. (d.1) the applicant breaches any condition of the permit; or

4. A new section 67.1 is added as follows:

- 67.1 (1) A Person to whom a permit has been issued pursuant to this Bylaw, and any Person carrying out an activity otherwise regulated, restricted, or prohibited by this Bylaw pursuant to such permit, shall comply with any terms or conditions forming part of the permit.

- (2) A Person shall not make any false or misleading statement or provide any false or misleading information to obtain a permit pursuant to this Bylaw.

5. Schedule 10 of the Bylaw is amended by adding the following to the beginning of the schedule, immediately after the title and before the penalty table:

Without restricting the generality of section 73 of the Bylaw, a fine amount of \$250.00 is established for use on Municipal Violation Tags and Violation Tickets for any offence for which a fine is not otherwise established in this Schedule 10 and for which a voluntary payment option is offered.

6. The Chief Administrative Officer is authorized to issue a consolidated version of Bylaw 18/2005 that incorporates the amendments made by this amending bylaw and otherwise conforms with the requirements of section 69 of the *Municipal Government Act*.
