13.1 Notwithstanding Section 13, starting at 12:01 AM Mountain Daylight Time on October 6, 2020 this Bylaw is in effect in a Public Place that is not a Civic Facility or Transit Property, only when the number of active COVID-19 cases in St. Albert reaches 25 or more as reported on the website of Alberta Health Services, and this Bylaw ceases to be in effect in a Public Place that is not a Civic Facility or Transit Property when the number of active COVID-19 cases in St. Albert drops to 15 or fewer and remains at 15 or fewer for at least 14 days, as reported on the website of Alberta Health Services.
