

I have attached two maps. The B&W map is a page from the Area Structure Plan for Kingwood that shows the Future Land Uses proposed for the Kingswood neighbourhood. The color map shows where the proposed subdivision (park) will be (YELLOW). On the color map, the BLUE shaded area is designated as future park (which could include a school) and the PURPLE shaded areas are designated as future low density residential (which would likely consist mostly of single detached houses). The ORANGE line is approximately where Kingswood Blvd would be extended to complete a ring road thru the neighbourhood.

At this time, the owner of these undeveloped lands has not indicated what plans are for the rest of the greenspace, nor the timing of any future development. The lands have been sitting undeveloped for some time now. The City has worked with the owner over the last few years to release the lands in the proposed subdivision, so that Kingswood could have a community park.

The City's Recreation and Parks department will be holding public engagement sessions to determine the actual design of the park, starting in August and then into the fall. Watch the City website for more
