Purpose

To facilitate the development of young aspiring artists from the St. Albert community by providing funding assistance for training, education, or a career advancement opportunity.

Policy

The legacy given to the community from the Lieutenant Governor of Alberta's Distinguished Artists Awards supports development of young artists in the St. Albert community by providing financial assistance for education and professional development and travel to showcase events and/or conferences.

Definitions

"Arts Disciplines" include visual arts, theatre, music, musical theatre, literary, film and new media, and multi-media.

"Aspiring Artists" means a young individual or youth group wishing to pursue a career or is pursuing a career in the arts.

"Career Advancement Opportunity" means attendance as a registered delegate at a conference or a participant at a career related workshop.

"Eligible Applicant" means either an individual or a group as further defined in the policy.

"Eligible Education, Training, Instruction, Professional Development" means a recognized workshop or program in a related arts discipline.

"Eligible Expenses" means an expense directly related to an eligible project for training, education or career advancement. Expenses could include registration fees, tuition fees, workshop fees, master class registration and/or travel fees to attend a national or international conference or workshop including flight and accommodation costs. This grant is meant for short term programs and opportunities that enhance artistic development beyond regular training.



"Group" means a group of 2 or more youth, with the majority of the group having permanent residence in the St. Albert community, who are pursuing a career in the arts.

"Ineligible Expenses" include capital items such as equipment purchases or rental fees, studio rehearsal space or recording time and post secondary tuition fees.

"St. Albert community" means being within the City of St. Albert boundaries.

"Youth Individual" means an individual aged 13 to 21 years who has permanent residence in the St. Albert community, and is pursuing a career in the arts.

Responsibilities

- 1. Applicants may expend funds only as specified in the application.
- 2. On an annual basis a subcommittee of the St. Albert Cultivates the Arts Society, as well as a City of St. Albert Community Services representative, shall review the applications and make funding recommendations to Council.
- 3. Applicants shall submit a final report to Community Services highlighting how the funds were utilized, the benefits received by the applicant, and how they might further contribute to the community. Final report forms are available from the Community Services department.

Standards

- 1. Applications shall be received in April of each year.
- 2. Preference will be given to applicants who have not received a grant previously.
- Consideration will be given to applications for programs, conferences or activities with a commencement date between January 1 – December 31. Submission deadline for all applications will be in April.
- 4. Grants shall be awarded by Council in May of each year Maximum funding awarded will be as follows:
 - Individual applicants: \$500
 - Group applicants: \$1000
- 5 Grant support is limited to the interest derived from the principle amount from the Lieutenant Governor of Alberta's Distinguished Artists Awards in addition to an annual allotment of \$1000 from the City.



- 6. The number and amount of grants awarded will be determined by the committee on an annual basis.
- 7. Unallocated funds shall be added to the principle amount.
- 8. The funds shall be held in a City of St. Albert reserve.
- 9. Successful applicants must wait one calendar year before re-applying for funding.

What is the Young Artists Legacy Award Program?

The Young Artists Legacy Award program provides financial assistance to young, aspiring artists from the St. Albert community.

The grant offers financial assistance to young aspiring artists by providing funding for:

- Short-term educational programs and/or professional development opportunities that enhance artistic development beyond a post-secondary experience,
- Travel assistance to showcase events and/or conferences.

The Young Artists Legacy Award Program is intended to fund one training, education or career advancement opportunity per individual or group within a calendar year. These grants are non-transferable and any unused monies will have to be returned to the City.

Who is eligible to apply for a grant?

Individuals aged 13 - 21 whose permanent residence is in the St. Albert community and are wishing to pursue a career in the arts or are pursuing a career in the arts.

A youth group, with the majority of the group having permanent residence in the St. Albert community and are pursuing a career in the arts.

Recipients of the Young Artists Legacy Award may not apply for next year's intake of grants.

Application Criteria

Applications will be evaluated on the following criteria:

- Opportunities for the applicants that will enhance artistic development beyond regular instruction.
- Preference will be given to new applications

When is the deadline for submitting applications?

The deadline for submissions is the second Thursday in April of each year. Upcoming intake date is: April 11, 2019.

Applications are due at the Community Services Department, ATTN: Andrea Gammon by 4:00 p.m.

Late or incomplete applications will not be accepted.

Who decides which artists receive awards?

Grant applications are reviewed by a sub-committee of the St. Albert Cultivates the Arts Society and by a City of St. Albert staff person.

What types of projects are funded?


Emphasis will be put on the facilitation and development of young, aspiring artists from the St. Albert community through project funding assistance for:

- Training,
- Education,
- Career advancement opportunities.

This grant is meant for short-term programs and opportunities that enhance artistic development beyond regular training.

Arts disciplines eligible for assistance include: visual arts, theatre, music, musical theatre, literary, film and new media and multi-media.





What types of projects are ineligible?

Equipment purchases, equipment rental fees, studio rehearsal space fees, recording time related to fundraising activities, as well as post-secondary tuition fees.

How much money can I expect to be granted?

The maximum amount per individual is \$500 and per group is \$1,000.

What are the funding guidelines?

- Applications are processed annually in April.
- Individuals or groups may receive one Young Artists Legacy Award per year.
- Applicants are required to submit a final report, including an expenditure report within 60 days of their project completion, verifying that the funds were used for the purpose awarded and the objectives were achieved.
- Successful applicants must wait one calendar year before re-applying for funding.

Will I be required to provide a final report of my use of the grant?

Yes, we require both a financial and narrative report. Future awards will be contingent upon the submission of a final report.

Definitions

St. Albert:

is defined as within the City of St. Albert boundaries.

Aspiring Artist:

is defined as a young individual wishing to pursue or is pursuing a career in the arts.

Eligible applicant: is defined according to the following:

Individual:

An individual, aged 13 - 21 years old, whose permanent residence is in the St. Albert community, and is pursuing a career in the arts.

Group:

A group of two or more youth, with the majority of the group having permanent residence in the St. Albert community, and are pursuing a career in the arts.

Eligible Education, Training, Instruction, Professional Development. A recognized workshop or program in a related arts discipline.

Career Advancement opportunity:

Attendance as a registered delegate at a conference or a participant at a career-related workshop.

- Travel assistance to showcase events and/or conferences



How did it get started?

- In 2011, St. Albert hosted the Lieutenant Governor of Alberta Distinguished Artist Awards at the Enjoy Centre.
- The Lieutenant Governor of Alberta Distinguished Artist Award is Alberta's most prestigious recognition of outstanding achievement in the arts.
- The awards are presented by the Lieutenant Governor of Alberta at a celebration hosted by a different Alberta community each year.

How did it get started (con't)?

The organizing committee gave the surplus funding for the gala to the City to put into a reserve, with the intention of creating a legacy fund, which would provide grants to emerging artists.

The reserve currently sits at \$23,119.28

The Current Policy - Funds

Currently, the policy states that:

- In terms of total funding: "Grant support is limited to the interest derived from the principle amount from the Lieutenant Governor of Alberta's Distinguished Artists Awards in addition to an annual allotment of \$1000 from the City."
 - Interest ends up being about \$400 a year.
- In terms of the funding being awarded to applicants, the "maximum funding awarded will be as follows":
 - Individual applicants: \$500
 - Group applicants: \$1000





The Current Policy – Eligibility

Who is eligible to apply for a grant?

- Individuals aged 13 21
- Permanent residents of St. Albert
- Applicants must wish to pursue a career in the arts or are pursuing a career in the arts
- In the case of a group, the majority of the members must have permanent residence St. Albert and are pursuing a career in the arts.
- Recipients of the Young Artists Legacy Award may not apply for next year's intake of grants.



The Current Policy – Eligibility (con't)

What, according to the policy, will the grant actually fund?

- "Career Advancement Opportunity" means attendance as a registered delegate at a conference or a participant at a career related workshop.
- "Eligible Expenses" means an expense directly related to an eligible project for training, education or career advancement. Expenses could include registration fees, tuition fees, workshop fees, master class registration and/or travel fees to attend a national or international conference or workshop including flight and accommodation costs. This grant is meant for short term programs and opportunities that enhance artistic development beyond regular training.
- "Ineligible Expenses" include capital items such as equipment purchases or rental fees, studio rehearsal space or recording time and post secondary tuition fees.







How is it awarded?

The policy states that, "On an annual basis a subcommittee of the St. Albert Cultivates the Arts Society, as well as a City of St. Albert Community Services representative, shall review the applications and make funding recommendations to Council."

Who is the St. Albert Cultivates the Arts Society (SACTAS)?

SACTAS is a "community-based volunteer society, whose purpose is to encourage the citizens of St. Albert to discover, experience and celebrate the creative endeavours of local artists and performers during *Alberta Culture Days*, scheduled annually in September."

- They have run StArts Fest or St. Albert Culture Days every year since



What does the City do?

The Application is pretty simple and is included with the information we sent you in advance.

Timeline

The policy very specifically states:

- that applications must be collected in April of each year and;
- that City Council will award the money every year in *May*.

This makes practical sense, as most of the applicants are looking for funding for summer programs.

Normally we'd be advertising the opportunity and already accepting applications by the end of February.

Why the rush?

Two reason:

- 1. As I mentioned before, in order to follow the policy that currently stands, we have to accept applications in April and head to Council by the end of May.
- 2. Currently, there is a mis-alignment between the current Young Artist policy and the Arts Development Advisory Committee Bylaw.
 - The Young Artist policy says that the St. Albert Cultivates the Arts Society will make recommendations to City Council regarding the recipients of the grant,
 - WHILE the ADAC bylaw says ADAC will make recommendations on the allocations funds regarding the grant.





COSA Grant Review

- The City is currently reviewing all the civic granting programs and findings are scheduled to be presented to council this week.
- Once council has determined their priorities, there will be a broader community conversation regarding civic grant funding starting in March.
- The Senior Advisor for Grants and Partnerships (Anna Royer) will be attending ADAC's next meeting to get your feedback.





Arts Micro Grant Program

- Depending on Council priorities, the results from Community Engagement, and your input, the Arts Micro Grant Program may or may not go to policy and on to council.
- Some history on the the Arts Micro Grant Program
 - Approved in the 2016 budget the Arts Micro Grant Program was originally intended to:
 - support community artists and Cultural organizations;
 - engage the community through the arts and culturally focused projects;
 - enhance and encourage a rich and vibrant cultural community.





Arts Micro Grant Program

- The Arts Micro Grant Program was created to enable the development of artists from the City of St. Albert by providing funding for:
 - community arts-based initiatives that are innovative and that encourage cultural diversity and participation.
 - educational opportunities for artists to hone their craft through professional development and peer to peer learning

A draft policy has been completed but not approved





Arts Micro Grant Program

- Moving forward:
 - The Senior Advisor for Grants and Partnerships will present findings at ADAC's March meeting
 - Community engagement proceeds
 - ADAC to determine how they want to proceed with arts granting programs



Three Paths Forward:

- 1.Cancel YALA for 2021.
- 2.Proceed with YALA policy change letting ADAC pick (or be) the jury endorsed by ADAC, CLSC, and approved by Council
- 3.Recommend (to ADAC, CLSC, and Council) that St. Albert Cultivates the Arts jury YALA for 2021.
