BL-20-033 Bylaw 32/2020 Temporary Mandatory Face Coverings Bylaw (1st, 2nd and 3rd readings)

That Bylaw 32/2020, the Face Coverings Bylaw, be read a first time.

Moved by Councillor Hansen

That Bylaw 32/2020 be amended:

1. by adding the following as a new subsection 2(e.2):

(e.2) "Public Place" means an indoor space open to the public by right or by express or implied invitation regardless of who owns or occupies the indoor space, and includes the area occupied by the driver and passengers in a Vehicle for Hire as defined in Schedule C of Bylaw 43/2000 the Business Licensing Bylaw but does not include an indoor space located within:

- (i) a school or other educational institution;
- (ii) a hospital or other health care facility;
- (iii) a child care facility;
- 2. by adding ",a Public Place" immediately after the words "Civic Facility" in Section 3.

(f.1) providing or receiving a service that requires personal consultation if that activity occurs in a closed office or meeting room and all participants in the personal consultation have at all times maintained physical separation of at least 2 metres from each other.

(a) That Section 13 be deleted and replaced with the following:

13. (a) Insofar as it addresses Face Coverings required to be worn in Transit Property, this bylaw comes into effect when it is passed;

(b) Insofar as it addresses Face Coverings to be worn in Civic Facilities other than Transit Property this bylaw comes into effect when the number of active COVID-19 cases in St. Albert as declared by Alberta Health reaches the level of 35 cases per 100,000 residents and ceases to be in effect if and when the number of active COVID-19 cases in St. Albert as declared by Alberta Health drops to or below the level of 20 active cases per 100,000 residents and remains at or below that level for at least 14 consecutive days.
