- 6.1.1 Opioid Discussion
 - Highlights from the discussion included:
 - Dec 6, 2021 Alberta Law Enforcement update noted a significant opioid spike from the previous weeks update.
 - Digital Overdose Response System (DORS) https://www.dorsapp.ca/
 The Digital Overdose Response System (DORS) app allows Albertans using opioids or other substances to summon emergency response to their location if they become unconscious.
 - Lockzone / Nalozone kit Naloxone is an opioid antidote and can reverse
 the potentially fatal effects of an overdose. Naloxone is effective against all
 opioids including: codeine, morphine, hydromorphone (Dilaudid), meperidine
 (Demerol), oxycodone (OxyContin), fentanyl, heroin, methadone,
 buprenorphine and others. Recommend adding a Lockzone kit to a regular
 first aid kit.
