Committee of the Whole Recommendation - Civic Agency Appointments Presented by: Mayor Crouse

RECOMMENDATION(S)

That members of the public be appointed to the City of St. Albert civic agencies; and, that previously appointed and newly appointed Assessment Review Board members be assigned to specific Local and Composite Assessment Review Boards for terms effective January 1, 2017 as specified in the attachments "Public Appointments to St. Albert Civic Agencies" and "Assignment of Assessment Review Boards" to the "Committee of the Whole Recommendations - Civic Agency Appointments" agenda report dated November 28, 2016.

PURPOSE OF REPORT

This report brings forward recommendations for appointments of public members to the City of St. Albert's civic agencies and assignments to the Local and Composite Assessment Review Boards.

BACKGROUND AND DISCUSSION

In total, 31 applications were received from the public, including individuals reapplying and new applicants.

In accordance with City Council Policy C-CC-12, Civic Agencies, Committee of the Whole met in camera on November 19, 2016 for the purpose of interviewing candidates and recommending appointments to fill vacancies on the City of St. Albert civic agencies.

Amendments to the *Municipal Government Act* in 2010 resulted in Council passing Bylaw 7/2010 establishing new Assessment Review Boards, including two Local Assessment Review Boards (LARBs), two Composite Assessment Review Boards (CARBs), and six one-member LARBs. All ARB members must complete provincially mandated training and the recommended new appointment of John Sugden to the Assessment Review Board is subject to his completion of the required four-day training program.
