### PURPOSE OF REPORT

This report provides Council an overview of the 2016 Operating Carry Forwards and Completed projects funded from reserves for consideration and recommendation to Council.

## COUNCIL DIRECTION

As per Council Policy C-FS-11, Operating and Capital Carry Forwards Policy:

#### "1. Operational Carry Forwards

a. A list of all operational carry forward requests shall be provided to Council's Standing Committee of the Whole, as part of the report on proposed year end transfers, for consideration and recommendation to Council.

b. Any operational project that has not been completed after being carried forward once shall be cancelled unless an extension is approved at the discretion of Council."

### BACKGROUND AND DISCUSSION

The purpose of a carry forward is to ensure that there is adequate funding available to complete projects or one time initiatives in a given timeframe without impacting tax or the operating budget in subsequent years.

#### Municipal and Utility Operating Carry Forwards

The recommended operating carry forward total of \$4.7 million as detailed in the attachment titled 2016 Municipal and Utility Operating Carry Forwards comprises:

Projects and Initiatives - Current Year

- \$1.9 million funded from the 2016 operating budget
- \$1.2 million funded from reserves
- Various projects and initiatives, including Inclusive Hiring Program, Employee Survey Action Plan, Canada 150, Crisis Intervention Support, and Finance Contract Staff required to support transition to the new organizational structure

Projects and Initiatives - Prior Year

- \$1.3 million funded from reserves
- Various projects and initiatives, includine Information Technology Long Term Plan, Land Use Bylaw Review and The Butterfly Project

Utility Projects and Initiatives

- \$293 thousand funded from reserves
- Various projects and initiatives, including the Utility Relief Grant Program, Storm water Rate Model and Water Purchase & Parts

#### Municipal and Utility Completed Operating Projects with residual balances

During the year, the City completed a number of operating projects funded from reserves. Of the completed projects, there was a net realized residual savings of \$54 thousand as detailed in attachment titled 2016 Municipal and Utility Completed Carry Forward Projects with Residual Balances. It is recommended that these funds be uncommitted for future Council approved projects.
