**Bylaw 34/2017 - Urban Beekeeping**

**RECOMMENDATION(S)**

That Bylaw 34/2017, Urban Beekeeping Bylaw, as amended, be read a third and final time.

**PURPOSE OF REPORT**

To present Bylaw 34/2017, Urban Beekeeping Bylaw to Council for consideration of third reading.

**COUNCIL DIRECTION**

On September 5, 2017 Council passed the following motion:

(BL-17-044)

That Bylaw 34/2017 be amended by adding the following requirement:

"that written consent is provided from all immediately adjoining neighbours"

**BACKGROUND AND DISCUSSION**

At the September 5, 2017 Council meeting, Bylaw 34/2017 received first and second reading. At that meeting, a motion to amend the bylaw was passed (see above):

The intent of the amendment has been incorporated into Bylaw 34/2017.

Administration considered the intent to the amendment and determined the word "immediately" was not required, because the definition of "Adjoining Neighbours" addresses location of neighbours with

the words "contiguous to another site".

The full definition for Adjoining Neighbours within Bylaw 34/2017 reads: "Adjoining Neighbours" means a site that is contiguous to another site along a common property line. If the subject site is located on a corner, an adjoining site includes a site that is adjacent across a rear lane, but not across a street.

The new sentence to address Council's motion is found in Part 2, 5.1 which reads: "Notwithstanding Section 5, at the time of initial application for an Urban Beekeeping Licence, the applicant must submit to the Licensing Authority written permission from all Adjoining Neighbours to install Hive(s) on the property."

One additional change was made under Section 5c; changing the word "City" to "Licensing Authority", because it is the Licensing Authority that will be reviewing the applications.
